

MEDICAID EXPANSION IN KANSAS:

Results from a Statewide Poll of Key Constituencies

There is strong support across key audiences for expanding Medicaid in Kansas, including **over two-thirds of voters**, a majority of **Republican Primary Voters**, and over **80% of Small Business Owners**.

Respondents were asked about a proposal to expand Medicaid in Kansas:

“As you may know, there is a proposal to expand Medicaid in the state to allow KanCare to cover more people. The expansion would eliminate all KanCare eligibility criteria except income. Under this proposal, anyone with a household income under 138% of the federal poverty level (for a family of three roughly \$32,000) may qualify for Medicaid benefits. It is estimated that 150,000 more Kansans would be eligible for KanCare under this proposal. Knowing this, would you favor or oppose expanding Medicaid in Kansas?”

In Their Own Words: Kansans on Medicaid Expansion

“With rising costs, young families can really use support.” – Republican Female, Harper County

“In my opinion, Medicaid expansion in the state will reduce economic disruptions and ensure a stable economy.” – Male Small Business Owner, Clay County

“The expansion of Medicaid could stimulate the economy by creating more jobs in the healthcare industry.”
– Democratic Male, Johnson County

“Access to health care can be life and death for some people. The ability to offer this service, to more who need it, is the right thing to do.”
– Republican Male, Johnson County

METHODOLOGY: On behalf the Sunflower Foundation, Public Opinion Strategies completed a statewide survey among three different audiences in Kansas between November 10-20, 2023:

- **500 Registered Voters** // Credibility Interval: $\pm 5.00\%$
- **516 Republican Primary Voters** // Credibility Interval: $\pm 4.92\%$
- **107 Kansas Small Business Owners** (with between 2-499 Employees) // Margin of Error: $\pm 9.47\%$

Respondents then heard about how this expansion in Medicaid would be funded and information about the impact it could have on Kansas:

% Convincing Reason to Support Medicaid Expansion



Expanding Medicaid means that **one hundred thousand of the poorest Kansans will gain access to affordable health care**, which will help prevent a family illness or health problem from turning into bankruptcy or the loss of a home.

82% 71% 93%

If Kansas does not expand Medicaid, it is likely that **more rural hospitals will close, jobs will leave the state, and low-income Kansans will suffer.**

If Kansas expanded its Medicaid program, it is estimated that **the state could gain as many as 10,000 new jobs**, boosting our economy.

A recent analysis by a K-State Professor showed that expanding Medicaid would **increase economic output and generate additional state tax revenue of more than \$55 million in 2024 and \$56 million in 2025**, helping to offset the cost of the Medicaid expansion to the state.

Expanding Medicaid in the state will not only **help rural hospitals and communities** but will **help alleviate general workforce issues and keep Kansas economically competitive.**

“The fact that it will help Kansas expand its workforce and help our economy go higher due to more jobs. The fact that if they won't, they will have to close hospitals down and cause a bigger problem.” – Republican Male, Harvey County

“To save people's lives, not ruin people economically, and add to our economy. Take care of those who are the weakest in society.” – Democratic Female, Johnson County
