MFAF Program and Purpose

- ► The Municipalities Fight Addiction Act
 - ► Gives direct funding to your municipality from the opioid settlement dollars
 - Intended to empower subdivisions with direct agency over spending, while still allowing subdivisions to seek additional funding from the KFAF
 - Restricted purpose funding
 - ▶ Intent is to focus on OUD/SUD abatement
 - ▶ Intent is to add to services, rather than supplant existing dollars
 - ▶ Demand Side v. Supply Side
- Administration Requirements
 - ► Keep dollars in a separate fund (doesn't need to be a separate account)
 - ► Track how much comes in and out in a given year
 - ▶ Submit an annual report on receipts and expenditures by March 1 every year
 - ▶ Be willing to answer questions about expenditures from AGO



MFAF: Questions

- ► Have you received money? How much?
- ► Have you spent money? How much? On what programs?
- ► How much can you expect to receive?



Getting Started and Identifying Needs

- Understand how Opioid and Substance Use Disorders are impacting your community
 - ► Look at Data Sources
 - ► KDHE Overdose Data Dashboard
 - ► Kansas Communities that Care Student Survey
 - ► Kansas Young Adult Survey
 - ► Talk with Local Community Leaders
 - ► Public Health or Medical Community
 - **►** Educators
 - ► Community Focused Coalitions or Organizations
- Bring in a wide variety of voices



Identify Knowns, Unknowns, and Unknown Unknowns about OUD/SUD in your community



Identify Needs: Questions

- ▶ Do we have a Substance Use Disorder problem in our community?
- ► How are we currently addressing SUD? Is it working?
- ▶ What do we want to achieve when addressing SUD?
- ► Who are we currently not serving/who currently needs help? Do we have the resources to provide any help?
- ➤ Are we talking to enough people/groups to know the full picture within our community? If not, who can we talk to and how hard is it to talk to those people?
- ▶ Who do we talk to if we have questions or are not sure where to go next?
